The Consulate General of the United Republic of Tanzania to Dubai and Northern Emirates presents its compliments to the Ministry of Foreign Affairs of the United Arab Emirates, Dubai Office, and has the honor to communicate the following to the Ministry, that the Revolutionary Government of Zanzibar, has since 13th of October, 2014, terminated the contract between the Government of Zanzibar and PHILTEX Corporation (Belize) Ltd, which has its offices in Dubai, in managing the Tanzania Zanzibar International Registrar of Shipping (TZIRS), and thus PHILTEX is no longer an authorized agent for the Government of Zanzibar.

In that regard, the Consulate General, kindly requests the Ministry to communicate this message to relevant Authorities of the Government of Dubai, to ensure that PHILTEX Corporation (Belize) Ltd does not carry out any activity of registration of ships on behalf of the Revolutionary Government of Zanzibar.

Furthermore, the Consulate General, wishes to inform the Ministry that, following this termination, it has officially appointed Zanzibar Maritime Authority, of P.O. Box 401 Zanzibar, and has entered into a contract for the Exclusive Ship Registration on behalf of the Government of Zanzibar. Therefore, from the date of termination of contract, PHILTEX Corporation (Belize) Ltd is hereby required to surrender ALL documents including stamps and flagships to Zanzibar Maritime Authority, of P.O. Box 401 Zanzibar.

Attached, please find a copy of an official communication from the Revolutionary Government of Zanzibar to Ship Owners, Ship Managers, Ship Operators, Masters, Recognized Organizations and all stakeholders.
